MENINGOCOCCAL VACCINATION RESPONSE FORM

New York State Public Health Law requires that all college and university students enrolled for at least six (6) semester hours or the equivalent per semester, or at least four (4) semester hours per quarter, complete and return the following form to SUNY Ulster Health Services.

The Advisory Committee on Immunization Practices recommends that all first year college students up to 21 years of age have at least 1 dose of a Meningococcal vaccine not more than 5 years before enrollment, preferably on or after the 16th birthday. Young adults 16 through 23 years of age may choose to receive the Meningococcal B vaccine series. College and university students should discuss the MenB vaccine with a health care provider.

Select one (1) of the following:

- I had meningococcal immunization within the past 5 years. The Vaccine record is attached.
- I will obtain the meningococcal immunization within 30 days from my private health care provider.
- I understand the risks of meningococcal disease and the benefits of immunization at the recommended ages. I have decided that I will NOT obtain immunization against meningococcal disease at this time.

MEASLES, MUMPS RUBELLA (MMR) IMMUNIZATION FORMS

NYS Public Health Law 2165 was passed in 1990 following an outbreak of measles on college campuses in 1989. This law requires that all college students who take six (6) or more credits, and who were born in 1957 or later must supply the college with proof of immunity for measles, mumps and rubella. Proof of immunity consists of two doses of measles, one mumps, and one rubella vaccine or immune bloodwork (titers.)

Veterans who have honorable discharges within the last ten years may receive a waiver while records are sought. Vaccination for measles must be from 1968 or later unless designated live vaccines. Mumps vaccines from 1969 and later and rubella vaccines from 1968 and later are acceptable doses. Pregnant women that cannot receive vaccines, they must have bloodwork done. Contact the SUNY Ulster Health Services if you feel you qualify for a medical or religious exemption so that proper documentation can be provided. Vaccine dates may be obtained in a printout form from your high school or doctors and attach to this form.

If you have no record or vaccination, you have blood titers drawn or you may need to be re-immunized. Call Health Services for recommendation to receive MMR vaccines. Students born before 1957 or taking less than six (6) credits, or online only courses do not have to provide MMR information.

NYS Public Health Law requires students to have record of MMRs to remain in classes. Failure to produce MMR records, can result in withdrawal from classes and you will be liable for tuition payments and fees as assessed.
